MEMORANDUM OF UNDERSTANDING (MoU)

CLAUSE 1: CO-OPERATION

- 2.4. Collaboration: the first party may collaborate in suggesting solutions to industrial problems of the second party through research and student projects.
- 2.5 There is no financial commitment on the part of the **Srinivas Institute of Technology**, **Mangaluru**, the first party to take up any program mention in MoU. If there is any financial consideration, it will be dealt separately.
