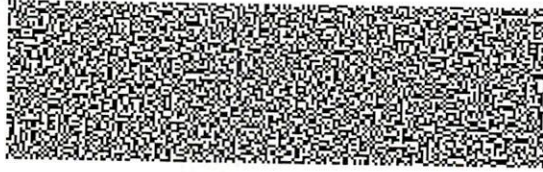

## **GENERAL TERMS OF THE UNDERSTANDING**

1. Srinivas Institute of Technology shall impart skill based training to students of Vivekananda College of Arts, Science and Commerce (Autonomous), Puttur in the area of Presentation skills/communication.
2. Vivekananda College of Arts, Science and Commerce (Autonomous), Puttur shall impart skill based training to students of Srinivas Institute of Technology in the area of Presentation skills/communication.
3. The Students of Srinivas Institute of Technology are given an opportunity to use the facilities of Vivekananda College of Arts, Science and Commerce (Autonomous), Puttur for learning purpose only.
4. The Students of Vivekananda College of Arts, Science and Commerce (Autonomous), Puttur are given an opportunity to use the facilities of Srinivas Institute of Technology for learning purpose only.
5. The faculty of Srinivas Institute of Technology can conduct training program for the students of Vivekananda College of Arts, Science and Commerce (Autonomous), Puttur.
6. The faculty of Vivekananda College of Arts, Science and Commerce (Autonomous), Puttur can conduct training program for the students of Srinivas Institute of Technology.

### **Financial Arrangements**

The financial obligations in meeting the requirements under various identified programmes and activities will be met as per the norms followed by the respective organisations. For example, joint publications, faculty or student's external service charges if any will be borne by the respective institute.

### **Validity & Renewal of the MOU**

This MOU will be valid for 5 years (Five years) from the date of signing. It may be renewed on mutual consent of both parties, such renewal to be agreed expressly in writing before the end of tenure.

### **Termination of MOU**

The agreement may be terminated by either party by giving advance notice of one month in writing.

## Jurisdiction and Dispute Resolution


This contract shall be bound by Puttur jurisdiction in Dakshina Kannada district. In case of any dispute, it shall be resolved mutually, in case of no mutual consent it will be solved by an arbitration bench of 3 members.
